The league operator and players agree to the following rules:

1. Entry fees and registration fee for the appropriate division in the form of a cashier's check or money order is to be submitted with this entry form. No personal checks!
2. All players must have a minimum of 25 games or 5 weeks of play since June 1st of the 2009 – 2010 season in their local league and meet ACS Amateur requirements. All players must be current members of their local league and a member of the Louisiana ACS Billiards Association.
3. **Check In:**
 - a. **Singles players agree to check in at the tournament site by 12 Noon, Friday, September 25th** for a player's meeting and calcutta, and be ready to play immediately following the calcutta.
 - b. **Mixed Scotch Doubles teams (must be male/female) agree to check in at the tournament site by 12 Noon on Saturday, September 26th** for a player's meeting and calcutta, and be ready to play immediately following the calcutta.
4. All players agree to the tournament dress code as follows: (a) collared shirts worn with slacks or dress jeans (no cutoffs, shorts, ripped or torn jeans or swimwear). (b) Clean, neat, closed-toed shoes. Ladies may wear sandals (**not flip-flops**).
5. Violators of any of the above rules may be disqualified from this tournament.
6. By signing this entry form, the players acknowledge that they have received and read the regulations of this tournament.

Driving Directions:

From the **East** (Lafayette):

Come in on I-10 heading west, go through Lake Charles, staying on I-10 West. Take exit 23, Cities Service Hwy/Industries exit (LA Highway 108), and go south by staying on the feeder road and taking the 2nd ramp which will take you around and over the overpass, you'll then be on Highway 108 south. As soon as you can, make your way over to the far left lane. Turn left at the red-light and take an immediate left onto the service road. Winners Choice is on your immediate right.

From the **North** (Highway 171):

Come in on Highway 171 south from DeRidder/Leesville until you hit I-10. Go West on I-10 and then follow the above directions as if you were coming in from Lafayette.

From the **North** (Highway 27):

Come in on Highway 27 south from DeRidder/Leesville until you hit I-10. Take I-10 east to exit 23, Cities Service Hwy, Industries exit (LA Highway 108), and go south by taking the first ramp. From this point, while coming off the exit ramp, it can be a little hazardous, but you'll need to either make your way across to the left land quickly and take the left turn at the red-light, or follow the exit ramp and enter the service road to the right and get turned around and cross back over the highway to Winners Choice.
